The services will be paid for in full when the services are ordered.

# **Refunds**

# Refunds for Goods

Refund requests must be made within 7 days after receipt of your goods.

We accept refund requests for goods sold on our Site for any of the following reasons:

- Good is broken; or
- Good does not match description.

Refunds do not apply to the following goods:

• All Shadowspec products, unless otherwise agreed upon with Tégō Shelters.

#### Refunds for Services

We provide refunds for services sold on our Site as follows:

• The services will be fully refunded if the services are cancelled at least 48 hours before the services were scheduled to be provided. Cancelled/refunded services DO NOT apply to Goods purchased in same Purchase Order.

### **Returns**

### **Consumer Protection Law**

#### **Limitation of Liability**

- Design Services Clause 1.0 The Customer agrees that Tégō Shelters is not a licensed Engineer or Architect, and assumes no legal liability and/or accountability for any damages that may occur during, or caused due to, the Design Process and/or Post Design Process. Any and all Design Services provided directly by Tégō Shelters are considered non-binding advice and/or sketches.; and
